#### **CAMPAIGN UPDATE**

#### "A Foundation for the Kingdom" On Its Way to \$1,000,000

**Board Votes to Push on with Campaign** 

With renewed interest from a large group of alumni, the Alpha Delta House Association board met Thursday, July 30 and voted unanimously to continue the fight to re-engineer our fraternity at Penn State. In a vote of 6-0, the board agreed to continue past the September 15, 2009 checkpoint milestone. The Board is pleased with the overwhelming response from alumni over the recent summer months.

The board agreed on a deadline of August 15, 2010 in order to reach our goal of \$2.25 MM. "Re-creating an entire organization doesn't happen overnight, in fact it has taken years, but we are finally seeing the previous apathy from members of our organization turn into renewed interest," said Bob Martin '87, who agreed to continue on as campaign chair through this date. "I think guys believe in our plan and are putting their money where the rubber meets the road." Bob attributes this renewed interest not only to the belief in the business plan, but the fact that we are finally getting our message out to our members.


The board agreed that now is the time to aggressively move forward. More alumni have made written pledges to the campaign in the last 6 months than they had in the previous two years, but much work still needs to be done in a short period of time. "The belief that Chi Phi, Alpha Delta can still provide a great character building and leadership experience that we experienced still remains," Martin said. He agreed to stay

on as campaign chair so long a key metric is met—reach \$1,000,000 in written pledges by December 31, 2009.

As of this writing, the campaign has received \$743,422.25 in written pledges (33% of our goal) from 127 out of 981 living alumni (13% of our alumni members). We have a specific strategic plan in place to get us to \$1 MM but we must act now. Hitting this preliminary goal doesn't assure us success but puts us well on our way to overall goal.

The strong possibility of providing a tax-deductible option to alumni once they begin making payment on their pledges is another sign of optimism. We are confident this will be a key factor to getting us to our overall goal. Join us now by completing the enclosed pledge form. #### Why Mark Kavanaugh '90 Pledged \$10,000 and Believes in Our Business Plan

Mark Kavanaugh '90 is an avid Penn Stater. Ask any of his friends, neighbors, coworkers or clients. And although he has spent the past 13 years working in Manhattan, most recently as a founding partner in the public accounting firm Cotter & Kavanaugh LLP, his Penn State experience still very much defines who he is.

"It's not hard to understand why I'm such a Penn Stater," Kavanaugh says. "As the son of a Penn State professor, and the youngest of five kids to attend Penn State, I lived my entire life in State College until I graduated in 1990."

#### A WORTHWHILE INVESTMENT

#### Our Plan to Re-Engineer Alpha Delta is an Exceptional Strategy

As the co-alumni association treasurer and member of the leadership committee for the capital campaign, "A Foundation for the Kingdom," I wanted to share our upcoming campaign strategy to assure that we are proper stewards of each individual's written campaign pledge.

With the pledges committed to date, we have exceeded the amount of support that Affinity Connection estimated we could raise in its initial Feasibility study.

The Board has decided to extend the go-no-go deadline, and are optimistic we can reach our first preliminary goal of \$1MM by December 31, 2009.

We are working on several measures that will mitigate the risk of pledging now, including:

- Making a substantial portion of the donations tax deductible.
- Confirming the fact that a portion of donations could be eligible for corporate matching.
- Crafting a legal structure that would return paid-in capital should the project fail and the house sold.
- · Arranging for the coverage of interim operating expenses so that payments on pledges can be deferred until the start of construction.

Once we meet our initial goal of \$1mm by December 31, 2009, through the focused strategic efforts of the 1985-89 and 1990-94 eras, we will have in place the era captains and class agents for other eras from other decades so we are successful at meeting our overall goal of \$2.5MM.

We are confident that if we put all of these measures into place, they will have a positive impact on additional substantial pledges and hopefully assure reticent alumni and their spouses that this is a worthwhile investment and our plan to re-engineer Chi Phi, Alpha Delta is an exceptional strategy.
